1.02. ADDITION: The following specification Sections were omitted from the bound Project Manual and are now included and attached:

- 1. Specification Section 002900 – OWNERSHIP DISCLOSURE: Consisting of 1 page total. This is a Mandatory Document to be included as stated on the FORM OF BID. This form does not require a signature page, but will require adding additional pages as needed per N.J.S.A. 52:25-24.2
- 2. Specification Section 004590 – POLITICAL CONTRIBUTION DISCLOSURE FORM Consisting of 4 pages total was referenced in the Project Manual, but the form was omitted from the Project Manual that was issued to bidders. Since this document is required by the lowest bidder prior to the award of the bid, the form is not required to be included in the bid, but is a mandatory document to be submitted prior to the Notice of Award.

1.03. Clarification: Section 002000 - Form of Bid, Bidder shall correlate all required documents in the order listed in the “Documents Accompanying Bid” as found on the Form of Bid and place an “X” in the box next to each item provided. **Addendum receipt to be acknowledged on Form of Bid.** Failure to provide all required documents and required number of copies may be cause for disqualification and rejection of bid.
